CIRCULAR

Sub.:- Circular regarding categorization of IT & ITES industries under 'Red/ Orange/ Green' category.

Ref.:- 1) Board's Circular vide letter No. BO/P&L Div. II/B-1681 dtd. 13/03/2008.

2) Minutes of Board's Categorization Committee meeting dtd. 05/11/2015.

3) Minutes of CAC meeting dtd. 27/04/2016.

This has reference with the above referred Board's Circular dtd. 13/03/2008 regarding processing of applications for Consent to Establish / Operate received from IT & ITES Parks. Board has covered IT & ITES parks in the regime of Consent Management and categorized IT & ITES Parks under 'Orange' category.

Central Pollution Control Board has issued modified directions dtd. 07/03/2016 regarding classification of industries into Red/ Orange/ Green/ White depending on pollution potential of the industry in which IT / ITES Park is not included in any category. But, industry which have installed D.G. Set of capacity greater than 5 MVA with average running 12 Hrs/day is categorized as 'Red' category; industry which have installed D.G. Set of capacity greater than 1 MVA and less that 5 MVA is categorized as 'Orange' category.

Board's Categorization Committee's decision dtd. 05/11/2015 to consider IT / ITES in Green category was reviewed in the Consent Appraisal Committee's meeting held on 27/04/2016 and policy decision was taken to categorize the IT & ITES industries/ park depending on pollution potentials based upon CPCB's modified directions dtd. 07/03/2016 regarding classification of industries.

Therefore, it has been decided to classify IT & ITES industries/ park depending on pollution potentials based upon CPCB's modified directions dtd. 07/03/2016 as follows:

IT & ITES Industry having D.G. Set of capacity	Category
Upto 1000 KVA	Green
>1000 KVA and ≤5000 KVA	Orange
>5000 KVA	Red

This Circular comes in force with the immediate effect by superseating all the earlier Circulars and Categorization Committee's decisions in this regard.
