Sub: Online submission of Monthly IW-1 Return....regarding

Sir,

As you may be aware that facility for online submission of IW-1 return by employers has started from 01st November 2018. However, it is observed that such returns are not being submitted online by concerned employers of establishments employing "International Workers" or the Indian workers comes under the definition of Indian International Workers. In view of above, employers will submit monthly IW-1 return online through the International Workers portal on the EPFO website <a href="https://www.epfindia.gov.in">www.epfindia.gov.in</a>. Offline IW-1 return will not be accepted in future.

It is also observed that, some employers are filling IW-1 Return incorrect. To fill up correct IW-1 return the following points may please be ensured:-

- 1. (IW-1 Return) International Workers under Para 2(ff)(a) Any Indian employee having worked or going to work in a foreign country with which India has entered into a social security agreement and being eligible to avail the benefits under social security program of that country, by virtue of the eligibility gained or going to gain, under the said agreement. Presently there are 18 Social Security Agreement Countries. Simply Indian workers posted in 18 SSA countries without Certificate of Coverage will be reflected in the report.
- 2. (IW-1 Return) International Workers under Para 2(ff)(b) An employee other than an Indian employee, holding other than an Indian Passport, working for an establishment in India to which the EPF & MP Act, 1952 applies. (Include all International Workers). (However, those who are coming from SSA Countries with valid COCs their Name, Nationality, COC No with duration may please be mentioned to reconcile data being received from FRRO, as they are excluded employees, hence Monthly pay and EPF No column is required to be mentioned blank).
